CIRCULAR

It is hereby notified for the information of all concerned that: -

Under section 74(4) of the Maharashtra Public Universities Act, 2016 the Hon'ble Chancellor, vide his office letter No. CS/Shivaji/ORD/2018/CR-115/814 dt.19/06/2019 has accorded assent to the amendment to the Ordinance No. 1) O.31, 2) O.31-A (New Ordinance) and 3) O.94: (A)(U.O.01) (New Ordinance) for giving facilities to physically disabled students (Divyang Students).

O.31 Attendance

For keeping terms in any class in any affiliated Colleges/Institute. University Department / School / Centre in any faculty a student shall put in attendance of a number of periods which will constitute at least seventy five percent of the total number of periods of each term and shall further satisfy the provisions of O.37.

O.31-A Attendance (for divyang students)

Divyang students in any affiliated / autonomous colleges / Institute, conducted colleges / University Department / School / Centre shall be exempted from provisions under ordinance No. O.31.

O.94: A (U.O.01.) Grace Marks for passing in each head of passing (Theory / Practical / Oral / Sessional / Project work etc.) (External / Internal) (for divyang students)

Divyang examinee shall be given the benefit of 3% grace marks of each head of passing (Theory / Practical / Oral / Sessional / Project work etc.) in External or Internal examination as follows:

Provided that the benefit of 3% of gracing marks under this ordinance shall be applicable.

- i) if the candidate fails in any one or more than one head/s of passing;
- ii) if the candidate fails to obtain required aggregate marks as per standard of passing if any

Provided further that this additional benefit of such gracing marks given in different heads of passing to Divyang Students shall not exceed 3% of the aggregate marks in that examination.

All existing Ordinances for grace marks are applicable and these are additional benefits to Divyang Students.

Provided further that all the such benefits shall be given as per directions received time to time by the competent authority / State Government.
